7 - Statement regarding the distribution of property remaining on liquidation


Any property remaining on liquidation of the Corporation, after discharge of liabilities, shall be distributed to one or more organizations in Canada carrying on similar activities.

8 - Additional provisions, if any

- (1) The directors may appoint one or more additional directors who shall hold office for a term expiring not later than the close of the next annual general meeting of members, but the total number of directors so appointed may not exceed one-third (1/3) of the number of directors elected at the previous annual annual general meeting of members.
- (2) The Corporation shall be carried on without the purpose of gain for its members, and any profits or other accretions to the Corporation shall be used in furtherance of its purposes.
